**ANNOUNCEMENT:** - Bradford & D.M.C will promote a Centre Restricted trial on 12<sup>th</sup> February 2012 for solo motorcycles. This event will count towards the Yorkshire Centre Championship with classes for Adult & Youth "A" solo classes :- Expert, Intermediate, Novice & Youth "A". (Championship Course)

**JURISDICTION:** - The event will be run under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting.

**ELIGIBILITY:** - Restricted to registered members of clubs affiliated to Yorkshire Centre ACU. All riders must hold a current ACU registration card or SACU license. Other riders must produce a license and start permission confirming insurance from their Federation

**MACHINES:** - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos; B1 Sidecars and TSR 8.

**START:** - 10.30 am At Yarnbury Lead Mines, Yarnbury, Grassington, North Yorkshire. Start area will be silent.

**AWARDS:** - Premier; The Timperley Cup. 1<sup>st</sup> Intermediate; MCN (Intermediate) Cup. 1<sup>st</sup> Novice; MCN (Novice) Cup. 1<sup>st</sup> "A" Class; An award.

**COURSE:** - Held entirely on private land. **Only one course will be marked.**

The number of laps and sections, together with a course closing time, will be announced on the day.

Sections shall be ridden in correct order on each lap. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed.

**Note :** This trial is held in a sensitive area. Any rider who fails to follow the course as marked or as otherwise directed, will be excluded.

**METHOD of MARKING:** TSR 22a; stop permitted. Ties will be resolved as per TSR 23

**PROTESTS:** - as per the National Sporting Code of the ACU, section 10.04
